

8. The required course “Social & Behavioral Research – Basic Course” will appear in “My Courses” under your Main Menu. Click on the hyperlink to the course to begin. There are eight required modules and thirteen optional modules. You must complete the quiz after each required module and score a cumulative score of 80% in order to pass.

9. To access your completion record, go to My Records, and save the PDF completion record by clicking on View-Print-Share under Completion Record. Verify that your completion record lists all required modules as “Completed.” Download a copy of this completion certificate, as you will need to include this as part of your IRB submission package in IRBNet.
